

Buffini Coaching *LIVE* Watch Party Contest – Official Rules for U.S. & Canada

NO PURCHASE NECESSARY TO ENTER OR WIN.

VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Sponsor

This Contest (“Promotion”) is sponsored by **Buffini & Company**, 6349 Palomar Oaks Court, Carlsbad, CA 92011 (“Sponsor”).

2. Eligibility

Open to legal residents of the fifty (50) United States, the District of Columbia, and Canada (excluding Quebec) who have reached the age of majority in their state or province of residence (18 years or older) at the time of entry.

Employees, officers, and contractors of Sponsor, its affiliates, subsidiaries, advertising and promotional agencies, and their immediate family members (spouse, parents, siblings, and children) or persons living in the same household are not eligible to participate.

4. Limit **one (1) entry per household, office or team**.

No purchase, payment, or membership is required. Internet access is required to participate. This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook or Instagram.

5. Winner Selection

At the conclusion of the Contest Period, Sponsor will review all valid entries.

The entrant will be determined at random by Sponsor and will be deemed the **Grand Prize Winner**.

In the event of a tie, the winner will be the entrant who submitted their entry first.

The Bonus Prize winner will be selected in a random drawing conducted by Sponsor on or about **December 3, 2025** and will be notified by email or phone.

No purchase necessary to enter or win. All other terms and conditions of these Official Rules apply to the Bonus Prize drawing.

8. Winner Notification

Participant will be notified by email or phone on or about December 1, 2025 if they are in the running for the grand prize, and must respond within one (1) business day to remain eligible.
